#### 4 First-aid measures

#### Description of necessary first-aid measures

Ingestion: Wash out mouth with water. Remove victim to fresh air and keep at rest in a

position comfortable for breathing. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting unless directed to do so by medical personnel. Get medical

attention if symptoms occur.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for

breathing. If not breathing, if breathing is irregular, or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention if adverse health effects persist or are severe. If unconscious, place in recovery position and get medical attention immediately. Maintain an ope airway. Loosen tight clothing such as a collar, tie, belt, or waistband. In case of inhalation of decomposition products in a fire, symptoms may be delayed.

The exposed person may need to be kept under medical surveillance for 48 hours.

#### 6 Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

For Non-Emergency Personnel: No action shall be taken involving any personal risk without suitable training.

Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. If a large number of containers are ruptured, treat as a bulk material spillage according to the instructions in the clean-up section. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate

## Methods and materials for containment and cleaning up

Small Spill: Stop leak if without risk. Move containers from spill area. Dilute with water and

mop up if water-soluble. Alternately, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of

via a licensed waste disposal contractor.

Large Spill: Stop leak if without risk. Move containers from spill area. Approach release from

upwind. Prevent entry into sewers, water courses, basements, or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite, or diatomaceous earth and place in container for disposal according to local regulations (See Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. Note: See Section 1 for emergency contact information and

Section 13 for waste disposal.

#### Precautions for safe handling

Avoid breathing gas. Avoid breathing vapor or mist. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Empty containers retain product residue and can be

hazardous.
